

## **iSelect Energy Monthly Offer (September'19)**

### **Promotion Terms & Conditions (effective 26/09/'19)**

1. These Terms & Conditions apply to the iSelect 2019 Energy Monthly Offer offered by iSelect Limited (ABN 48 124 302 932) and Related Body Corporates of iSelect (iSelect). iSelect offers Qualifying Customers who purchase an Eligible Energy Product during the Offer Period, to go into the draw to win an eGift Card and experience to the value set out in clause 10 (the Offer).
2. We recommend that you read these Terms & Conditions in full. Participation in the Offer is deemed acceptance of these Terms & Conditions. For any questions relating to the Offer, please contact iSelect on 13 19 20.
3. By participating in the Offer you consent to the use of your personal information for marketing purposes in accordance with iSelect's privacy policy (available at [www.iselect.com.au](http://www.iselect.com.au)) and for the purposes of processing and conducting the Offer (which may include disclosure to third parties).
4. This Offer is not available in conjunction with any other offer or promotion offered by iSelect or any Related Body Corporate.
5. These Terms and Conditions can be changed or withdrawn at any time by iSelect without notice.
6. iSelect reserves the right to disqualify any individual from entering the Offer who:
  - (i) is involved in any way with interfering or tampering with the Offer including any activation or fulfilment process; or
  - (ii) iSelect considers in its sole discretion has acted dishonestly or fraudulently in claiming the Offer; or
  - (iii) iSelect considers has acted in a way which is contrary to the spirit of the Offer; or
  - (iv) iSelect considers has failed to comply with these Terms and Conditions.

#### 7. In these Terms & Conditions:

"Eligible Energy Product" means any electricity or electricity and gas bundle (but not including "gas only") purchased through iSelect or a Related Body Corporate of iSelect (excluding InfoChoice Pty Ltd, General Brokerage Services Pty Ltd or any of their Related Bodies Corporate);

"Qualifying Customer" means a person who satisfies the criteria in clause 9; and

"Related Body Corporate" has the meaning given to it in the Corporations Act 2001 (Cth).

#### **THE OFFER**

8. The Offer Period is 12:00am (AEDT) on 26<sup>th</sup> September 2019 to 23:59pm (AEDT) to 21<sup>st</sup> November 2019.
9. To qualify for the Offer, a Qualifying Customer must meet the following criteria:
  - (a) be an Australia resident aged 18 years and over;
  - (b) purchase an Eligible Energy Product by calling 13 19 20 or visiting [iselect.com.au](http://iselect.com.au) during the Offer Period;

10. The Offer value of each offer prize is as follows:

Each eCard will be emailed by Edge PRI to the Qualifying Customer within 90 days of purchase. The eCard will be sent to the email address provided by the Qualifying Customer at the time of purchasing the Eligible Product. Neither iSelect nor Edge PRI will be responsible if the Qualifying Customer provides an invalid or incorrect email address.

14. The Offer is limited to an eCard to the value of AU\$500 for the “Winner” Qualifying Customer and AU\$200 for the “Runner-up” Qualifying Customer. The Offer and eCard is not redeemable for cash or any alternative form of credit.
